Investment Fund

- We have an investment fund separate from the operation
- Its purpose
 - Pay dividends in case the operating company is not able
 - Cover costs associated to the Family / Family Council
 - Pay for our SOCIAL DIVIDEND – by head count

 - Housing down payment – G4, G5
 - Medical Insurance – G4, G5, G6
